- The New Village Hall Fund had seen a substantial increase in income because of the S106 and Turbine contributions. Payments were now being made for the construction of the new hall.
- Overall the funds have increased from £59,760.14 at the start of the year to £400,291.64, with £18,850.50 for the Village Hall and £381,441.14 for the New Village Hall Fund.

The Chair invited those present to offer their service as a trustee or support in any capacity to help in the running of the hall or a function. Also, he asked those present to canvass others to assist.
